Staff Report: Facilities Liaison

Zoom meeting held on March 1, 2023 with Joselito Lacson, designer, President Karen Macedonio and Director Richard Macedonio

**8051/8101 Bay Ave:**

The roof repair of the fire damage on the northwest corner of the building is part of the structural element that distributes the weight of the building. The repair of the exterior integrity of the building needs to be completed before the interior is addressed. EKHCD has existing contracts with a designer and a structural engineer and the plans that will need to be submitted to Cal City Planning department for approval are in the process of being developed. We have scheduled an onsite meeting with both the engineer and the designer on Saturday March 18, 2023 to go over the final details.

In addition, we have a walk-through scheduled with a team from a prospective tenant on March 23, 2023, to talk about their use of a portion of the building.

**N Loop Properties:**

The plans for the exterior patio at 9300 N Loop have been completed and are ready to go to bid. EKHCD is working on developing the documents for the RFP.

The plans for the concrete pathway at the 9300 N Loop building have been completed and are ready to go to bid. EKHCD is working on developing the documents for the RFP.

The Tenant Improvements for the east side of the 9300 N Loop building are in the initial design stages, and we will be scheduling a meeting with the tenant to discuss next steps.
